Actions You Must Take

- All valid write-in votes cast for the above-listed candidates must be tallied. Please advise the appropriate city and township clerks to instruct their precinct boards to record any valid write-in votes cast for the indicated candidate(s) for Governor, US Senator, and any other district listed above that falls within your county.
- A write-in vote cast for an individual who has *not* filed a Declaration of Intent *does not count* and must not be recorded by the precinct board. Similarly, a write-in vote cast for an individual who filed a Declaration of Intent does not count unless the office for which the write-in vote was cast corresponds to the office identified on the Declaration of Intent. Write-in votes which do not count for the above reasons are *not* considered when determining whether an *over vote* has occurred. - If you accepted any Declaration of Intent filings from write-in candidates seeking the office of U.S. Representative in Congress, State Senator, State Representative or Probate Court Judge who were required to submit the form to your office, please fax a copy of the Declaration of Intent forms submitted by the candidates to the Bureau as soon as possible if you have not done so already.
