

NOTICE OF LAST DAY OF REGISTRATION FOR THE SPECIAL ELECTION TO BE HELD ON TUESDAY, MAY 2, 2017 KALAMAZOO COUNTY, MICHIGAN

TO THE QUALIFIED ELECTORS:

Of the Kalamazoo County Townships of Alamo, Brady, Charleston, Climax, Comstock, Cooper, Kalamazoo, Oshtemo, Pavilion, Prairie Ronde, Richland, Ross, Schoolcraft, Texas, Wakeshma and the Cities of Galesburg, Kalamazoo, Parchment and Portage; Barry County Townships of Barry, Johnstown and Prairieville; Calhoun Townships of Bedford and Leroy and the City of Battle Creek; and St. Joseph County Townships of Leonidas, Mendon and Park.

COUNTIES OF BARRY, CALHOUN, KALAMAZOO AND ST. JOSEPH, STATE OF MICHIGAN

PLEASE TAKE NOTICE that a Special Election will be held in the Barry County Townships of Barry, Johnstown and Prairieville; the Calhoun County City of Battle Creek and the Townships of Bedford and Leroy; the Kalamazoo County Cities of Galesburg, Kalamazoo, Parchment and Portage and the Townships of Alamo, Brady, Charleston, Climax, Comstock, Cooper, Kalamazoo, Oshtemo, Pavilion, Prairie Ronde, Richland, Ross, Schoolcraft, Texas and Wakeshma; and the St. Joseph Townships of Leonidas, Mendon and Park on Tuesday, May 2, 2017. The last day for receiving registrations for the Special Election will be Monday, April 3, 2017. Persons residing in the above Townships/Cities registering after 5:00 p.m. on Monday, April 3, 2017 will not be eligible to vote at the Special Election. Persons planning to register must determine when the office of the Township Clerk or the City Clerk or the office of the County Clerk or the Secretary of State drivers license bureau will be open for registration in person. Registration may also be made at the specified agency for clients receiving services through the Human Services Department, the Department of Community Health, Michigan Works and some offices of the Commission for the Blind and at the military recruitment offices for persons enlisting in the armed forces. Registration by mail may be used by obtaining and completing a Mail Voter Registration Application and forwarding to the election official as directed on the application by the close of registration deadline. Only persons who have registered as electors with the appropriate Township Clerk, City Clerk, County Clerk or through registration at a Secretary of State drivers license bureau or at any specified agency or military recruitment office or by using an official mail registration application, are registered electors of the above Township/City.

PERSONS ENTITLED to be registered voters in the Counties of Barry, Calhoun, Kalamazoo and St. Joseph must possess the following qualifications on or before the day of the Special Election: (1) a citizen of the United States; (2) not less than 18 years of age; (3) a resident of the State of Michigan and the local municipality for not less than 30 days prior to the Special Election (MCL 168.492). In addition, qualified electors must be registered to vote not less than 30 days prior to the Special Election (MCL 168.497).

KALAMAZOO COUNTY CONSOLIDATED DISPATCH PROPOSITION FOR 911 SYSTEM FUNDING

Shall the County of Kalamazoo, Michigan, be authorized to assess a surcharge on all devices capable of accessing the 9-1-1 system located in Kalamazoo County of up to \$2.30 per month for a period of five (5) years, July 1, 2017 through June 30, 2022, both inclusive, to be used exclusively for the funding of 9-1-1 emergency telephone call answering and dispatch services within Kalamazoo County, including facilities, equipment and maintenance, and operating costs?

KALAMAZOO REGIONAL EDUCATIONAL SERVICE AGENCY REGIONAL ENHANCEMENT MILLAGE RENEWAL PROPOSAL

This proposal will allow the intermediate school district to continue to levy regional enhancement millage that expired with the 2016 levy. Pursuant to state law, the revenue raised by the millage will be collected by the intermediate school district and disbursed to local public school districts based on pupil membership count.

Shall the limitation on the amount of taxes which may be assessed against all property in Kalamazoo Regional Educational Service Agency, Michigan, be increased by 1.5 mills (\$1.50 on each \$1,000 of taxable valuation) for a period of 3 years, 2017, 2018 and 2019, to provide operating funds to enhance other state and local funding for local school district operating purposes; the estimate of the revenue the intermediate school district will collect if the millage is approved and levied in 2017 is approximately \$11,061,859, which funds will be disbursed as required by statute to the following school districts: Climax-Scotts Community Schools, Comstock Public Schools, Galesburg-Augusta Community Schools, Gull Lake Community Schools, Kalamazoo Public schools, Parchment School District, Portage Public Schools, Schoolcraft Community Schools and Vicksburg Community Schools (this is a renewal of millage which expired with the 2016 tax levy?
