- ❖ County Commission District 1 can be circulated in City of Battle Creek Precincts 3, 4, 5, 11, 20 and 22, and City of Springfield Precincts 1 and 2.
- ❖ County Commission District 2 can be circulated in City of Battle Creek Precincts 7, 10, 12, 13, 15, 16, 17 and 21.
- ❖ County Commission District 3 can be circulated in City of Battle Creek Precincts 1, 2, 6, 8, 9, 14, 18, 19 and 23.
- ❖ County Commission District 4 can be circulated in the Charter Townships of Bedford Precincts 1, 2, 3 and 4, and Pennfield Precincts 1, 2 and 3, and the Township of Convis.
- ❖ County Commission District 5 can be circulated in the Charter Township of Emmett Precincts 1, 2, 3 and 4, and the Townships of Athens, Leroy Precincts 1 and 2, and Newton.
- ❖ County Commission District 6 can be circulated in the City of Marshall Precincts 1 and 2, and the Townships of Burlington, Eckford, Fredonia, Marengo, Marshall Precincts 1 and 2, and Tekonsha.
- ❖ County Commission District 7 can be circulated in the City of Albion Precincts 1, 2, 3, 4, 5 and 6, and the Townships of Albion, Clarence, Clarendon, Homer, Lee and Sheridan.

- ❖ County Commission District 2 can be circulated in City of Battle Creek Precincts 7, 10, 12, 13, 15, 16, 17 and 21.
- ❖ County Commission District 3 can be circulated in City of Battle Creek Precincts 1, 2, 6, 8, 9, 14, 18, 19 and 23.
- ❖ County Commission District 4 can be circulated in the Charter Townships of Bedford Precincts 1, 2, 3 and 4, and Pennfield Precincts 1, 2 and 3, and the Township of Convis.
- ❖ County Commission District 5 can be circulated in the Charter Township of Emmett Precincts 1, 2, 3 and 4, and the Townships of Athens, Leroy Precincts 1 and 2, and Newton.
- ❖ County Commission District 6 can be circulated in the City of Marshall Precincts 1 and 2, and the Townships of Burlington, Eckford, Fredonia, Marengo, Marshall Precincts 1 and 2, and Tekonsha.
- ❖ County Commission District 7 can be circulated in the City of Albion Precincts 1, 2, 3, 4, 5 and 6, and the Townships of Albion, Clarence, Clarendon, Homer, Lee and Sheridan.
